## **“Back-To-School” PROMOTION**

### **Official Rules**

#### **Promotional Giveaway Summary**

Use your Alliance Bank Consumer Debit Card on or between 8/26/19 and 9/27/19, and you could win a \$500 Alliance Bank Gift Card.

Each time you use your Alliance Bank Consumer Debit Card to complete a purchase authenticated by your Signature or four-digit Personal Identification Number (PIN) on or between August 26, 2019 and September 27, 2019, your name will be entered to win.

Alternative methods of entry for the promotion are described below as no purchase or obligation is necessary to enter or win.

#### **Official Rules**

**NO PURCHASE, TRANSACTION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER THIS PROMOTION.**

**1. How to Enter.** There are two ways eligible individuals may enter the Promotion: automatic entry and by US mail.

- a) Automatic Entry. Each time you make a purchase using your Alliance Bank Consumer Debit Card, your name will be entered to win. Purchases of goods must be at a participating merchant location in the United States. Your account must be in good standing, and the entry from your purchase must post on or during the Entry Period.
- b) Entry without purchase or obligation by US Mail. You may enter by hand-printing your name, address, city, state, ZIP code, and daytime and evening telephone numbers (including area code) on a 3" X 5" card, and mailing the card via US mail, in a #10 envelope with postage affixed, to: Alliance Bank/ P.O. Box 500/Sulphur Springs, Texas 75483 Attn: Back-To-School Promotion. Each mail-in entry will count as one entry into the drawing. Mail-in entries must be postmarked on or after August 26, 2019 and must be received on or by September 27, 2019 in order to be eligible. Each mail-in entry must be hand written and mailed in a separate, postmarked stamped envelope. Entries that have been generated by a script, macro or any other automated means will be deemed void. Entries that are mechanically reproduced, copied, illegible, incomplete or inaccurate are void. You need not be an Alliance Bank customer to participate or win. Entries become the property of the Sponsor and will not be acknowledged or returned.

**3. Eligible Consumer Debit Cards.** Only Consumer Debit Cards issued by Alliance Bank are eligible. Only PIN-authenticated purchases or Signature-based purchases qualify, (ATM transactions, and returns do not apply) for the promotion.

**4. Eligible Entrants.** The Promotion will be open to all who have submitted Promotion entries as described above and who are legal residents of the United States of America and who are eighteen years of age or older as of the date of entry; residents of Florida, New York, Colorado, and Rhode Island are not eligible. The following persons are also not eligible to enter the Promotion: (a) Employees of each Sponsor, and

their subsidiaries and affiliates, and (b) any immediate family members of any such employee, whether living in the same household or not, and (c) anyone living in the same household, whether related or not. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension. Sponsor reserves the right to verify the eligibility of all entrants. Potential winners will be notified by overnight or U.S. mail and/or telephone the week following the drawing. Potential winners will be required to sign an affidavit of eligibility/liability release and where legal, a publicity release, and Federal and State tax release, and return these documents, properly executed, via overnight mail, within seven (7) days of date of issuance of notification.
